STUDENT CODE OF CONDUCT

Student Visions requires its students to abide by a Code of Conduct. This Code allows for the dismissal of any student who is found to be in violation of its terms. The goal of this Code is to create positive peer pressure among students to behave in a positive and responsible manner, while discouraging negative behaviors. The Code requires:

That each student dress appropriately for the classroom and any other facility in which Student Visions functions are conducted.

That each student be and remain at assigned locations on time as scheduled.

That each student treat other students and Student Visions personnel with proper respect and courtesy.

That each student treat and use Student Visions equipment and facilities only for Student Visions' purposes and in a non-abusive and appropriate manner.

That each student respect the confidential information and proprietary rights of Student Visions as to its corporate organizational structure, methods of operation, software, data and other collected and/or sorted information, accounts, files and like. No disclosure of proprietary material, information or materials or other items shall be made to any third person or organization. Any and all proprietary material or software used by student as a part of his or her relationship with Student Visions shall be used only as intended.

That each student participate in and attend scheduled community service events or projects, unless expressly excused in writing by the President of Student Visions.

That each student take the personal responsibility to contact Student Visions personnel to schedule classes, advise as to the necessity of excused absences, or in scheduling attendance at community service events or projects rather than have the parent or guardian make such contact. All involved understand that such is a part of an important learning experience for the student. Parent or Guardian agrees to and hereby authorizes such direct contact between the student and Student Visions personnel.

The student agrees to contact Student Visions no less than once per month for the purpose of scheduling, then attending a personal interview at the office of Student Visions to discuss the student's progress and any need to change the mix of services of Student Visions. In the event the student is beyond a two-hour drive from Student Vision offices when such interview is required, a telephone interview followed by a

written and signed synopsis of the matters discussed may be substituted with the permission of Student Visions.

The Code forbids, while involved in any activity of Student Visions:

The use of drugs, alcohol or any tobacco products, or being in possession of any weapon while involved in a Student Visions activity. To assure compliance with such, Student Visions reserves the right to require, and student and client agree, that student will submit to any random blood or drug test (at client's expense) that Student Visions deems necessary. Serious violation of said Code of Conduct by Client(s) or Student may, at the sole discretion of Student Visions, cause the dismissal of Student from the program;

The use of foul language or any act of violence, or any other conduct while involved in any Student visions activity that is disruptive of others or could cause Student Visions to be held in disrepute;

Any statement, conduct or other act toward another while involved in any Student Visions activity that creates a hostile or uncomfortable atmosphere and which is based on the race, color, religion, gender, national origin, veteran's status, marital status, age, disability, sexual preference, or any other status protected by law of a fellow student, Student Visions personnel, client or parent or visitor in or around a facility in which a Student Visions function is conducted;

The mistreatment of or unauthorized use or abuse of Student Visions equipment, materials or facilities;

The downloading of proprietary material, data or information of Student Visions unto personal CDs, floppy disks, USB thumb drives or other method of data collection, or the use of such materials other than as intended;

The use of cell phones or acceptance of personal calls while involved in a class or other assigned activity. Such use is permitted on rest or lunch breaks while on Student Visions premises.

The undersigned student and his or her parent or guardian states that he or she has read and understands the Student Code of Conduct and agrees to abide by its terms. Violation of such Code may lead to dismissal from the program or, should monetary damage be suffered by Student Visions, to civil liability.
